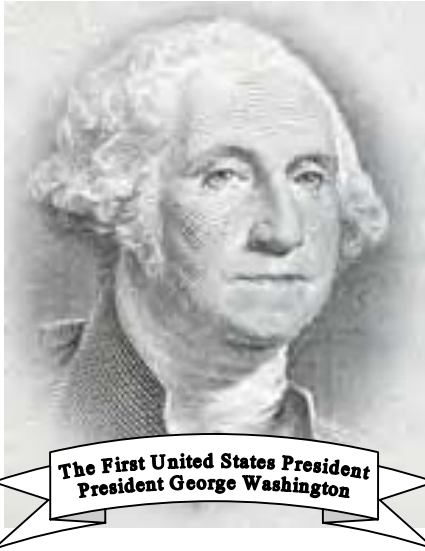

Those are the questions that we Whiggs most

double "G" spelling of the word, regardless of

case, is intended to maintain a distinction
between the remnants of what we believe to be

contemporary beliefs of any now existing
organizations that have or may yet incorporate
the word "Whig" and spelling in the title of their
organization. The double "G" is to stand for

Parliament was driven out of his American
Colonies, save Canada.

PREAMBLE

When in the course of human events, it
becomes necessary to confront a subversive
tyrannical political regime, we must call
upon all the good Whigs of our nation, to
band together as one against these despots,
to restore order in the midst of our present
political and fiscal chaos with the Whig
standard of rule by "LAW," not by "MEN."

ARTICLE I

Name:

The name of this organization shall stand for good government and shall be The American Federation of Whiggs (hereinafter referred to as “the Whigg Federation”). The name of the members of the various organizations formed under the Whigg Federation shall be the American Whiggs and/or Whiggs.

ARTICLE II

Purposes:

The following thirteen general directives shall guide the Whigg Federation, although stated purposes shall not limit the scope or direction of the organizational program.

SECTION 1. CIVIL LIBERTIES

The American Whiggs shall preserve our individual liberty and property rights, by restraining the sovereign authority, i.e., the government, through reestablishing and maintaining a wise & frugal limited government, in true republican form, as it was established and guaranteed by the Constitution of the United States of America. A government, which in providing for the common trade and defense, shall only restrain men from actually injuring one another, but shall leave them otherwise free to regulate their own pursuits of industry & improvement, and shall not take from the mouth of labor the bread it has earned.

SECTION 2. RULE BY LAW

The American Whiggs shall maintain a nation ruled by law not by men. The standard adhered to will be, that the intent of the lawmaker is the law, not any extraneous or contemporary political interpretation, that may arise at any time after its passage. The Whigg Federation shall at all times, do whatsoever is within its power to actively pursue any and all public

officials that subvert the true intent of our laws. The Whigg Federation shall not tolerate any judge, upon any bench in the American states, that does not at all times, except in equity proceedings, adhere to the intent of the law. The American Whiggs shall publicly rescind or remove any political Whigg endorsement of any such judge.

SECTION 3. GENERAL WELFARE

In the preamble of the Constitution of the United States of America, the phrase, “promote the general welfare,” means exactly what it says. The “GENERAL” welfare not the exclusive welfare of a select few at the expense of the others. Davey Crockett a founder of the first American Whig Party, acknowledged such during his second term of office in the Congress in refusing to support a bill that would provide financial relief to the widows of military officers whom were killed in the Indian wars of that day. The meaning of the Constitutional phrase is the same today. The federal government of the United States is not empowered by its constitution to engage in charity with our public treasury.

To this end, the American Federation of Whiggs shall work to encourage and protect the efforts of the American people to provide for their own security and the security of their neighbors. The Whigg Federation shall exempt from any taxation the personal and private trusts that are solely for the purposes of providing medical, retirement and disaster relief and funding to their private creators, a select segment of society or the general public. These trusts will be created without regard to national origin, religion, race, color or the creed of the Americans that they are intended to benefit.

The Whigg Federation shall work to provide total retirement credit for every year of every American’s working life. These credits shall

accrue from one job to another during the productive life of each working American.

SECTION 4. STATESMANSHIP

The American Whiggs shall engage in the practice of statesmanship at all times, and shall never engage in the politics of selling their individual support or voting powers. The American Whiggs shall to this end work for the amendment and enforcement of both state and federal constitutions, banning all legislative bills from embracing more than one topic and containing more than one item. The American Whiggs shall further the elimination of the practice of wholesale politics found in the costly and unneeded primary elections of our United States. This shall be done legislatively if not judicially, abolishing all such forms of the primary elections where the total public costs of such elections cannot be apportioned upon the participating political parties or individuals according to the number of votes received by that party. The general public only has a vested interest in selecting individuals to hold public offices in a general election of the state or federal government. The general public does not have any legitimate interest in selecting individuals solely to be the selected candidates of a political party to which the general public does not belong. Thus the American Whiggs shall at all levels of their organizations, select their candidates for public office through the process of a caucus at the applicable organization level.

SECTION 5. DOMESTIC SECURITY

People who cannot produce their own food are at a disadvantage, and are very likely to become the victims of wage slavery. The American Whiggs shall do whatever they can to promote the domestic security and stability of the American society through agriculture and commerce by family owned and operated businesses, farms and home garden lots. The American Whiggs shall work to return the rights regarding the use

of property to the owners of it, whenever there is no actual public health or safety concern with that use. The American Whiggs shall work to protect the family owned home and lands from the predation and confiscation by federal, state and local developers, taxes, laws and needless regulation.

SECTION 6. MONETARY MATTERS, BANKING & FINANCE

The Whigg Federation shall work for the rescission of money debt founded upon security fraud, and not founded upon a lawful consideration of money as established by the common law and historic statues of fraud of these United States of America. The adage being, "It takes Money to make Money!" Such common law was intended as a bulkhead against the effects of inflation caused by both counterfeiting and all types of security frauds. The Whigg Federation shall work for the reestablishment of an intrinsic money of account as historically established and preserved by the Constitution of the United States of America, yet unamended or used to provide anything other than dollars of silver as the money of account and other gold and silver coins as the lawful money and currency of the United States of America.

SECTION 7. COMMERCE AND INDUSTRY

The Whigg Federation shall, to aid and protect the commerce and industry of the United States, promulgate and enforce tariff, impost, duty and excise tax laws within the power granted to the Federal Government by the Constitution of the United States of America. The Whigg Federation shall promulgate and enforce laws for the protection of production workers from unfair and unethical labor, manufacturing and trade practices, such as foreign outsourcing and industrial relocation. The Whigg Federation shall provide a legislative means for workers to acquire the industrial

infrastructure of those companies or corporations that no longer wish to continue doing their manufacturing business in the United States. While doing all of this that is absolutely necessary, the Whigg Federation shall adhere as closely as the circumstances permit, to the economic policies established by Adam Smith in his book "The Wealth of Nations." Further, the Whigg Federation in not taking from the mouth of labor the bread it has earned, shall strive for a harmonious judiciary that shall afford the laboring class the same standard in respect to property and capital as it has done for the rich capitalists. The original par value of the property be it merely labor or a capital investment, is not taxable except by a direct and apportioned tax under the Constitution of the United States of America.

SECTION 8. LIMITATIONS

The Whigg Federation shall act as the sole national organizational body for all state or local Whigg Parties and Whigg organizations in the American states and abroad.

SECTION 9. EDUCATION

The Whigg Federation shall make known and promote the principles, values, and ideals of the Whigg Party among the citizens and students of the American states and their universities and colleges. The education of just how the system is suppose to work, from business entities to the welfare system to the justice system based upon accurate historical and legal precedents shall be taught and required to be known by each and every high school graduate.

The English language, that the founding history of our republican form of government and laws, have been made in, shall be the primary language taught in our schools. A good proficiency in the English language and proper grammar shall be a requirement

to graduate from high school or be considered for U.S. citizenship.

High school or lower grade students will be taught to know the various ways to start a business, the difference between sole proprietorships, partnerships, and corporations. They will be taught to know how to start one of these businesses and dissolve them. Because citizens should know what various patents, copyrights and trademarks are, and how to get one, this will be taught in every high school.

By the time a person is old enough to vote or die for their country, they should know how its government works in depth. A course taught every semester, every year from either middle school, junior high school, or within the high school level should be sufficient. A solid criminal justice course should be part of the curriculum, as would a course in general equity proceedings. Every high school graduate should know how to file general complaints within the proper court, how to arrange pleas and motions, so that any courtroom activities in their future will not be foreign to them. This will result in every citizen having access to a more informed jury pool as a final check and balance on a subversive, political judiciary. A republican society is better off educated, the best way to fight tyranny in a system like ours is to fight the ignorance of the people.

SECTION 10. DOMESTIC MISSION

The Whigg Federation shall develop business skills, political skills and leadership abilities among the citizens and students of the American states, as preparation for future service by them to the Whigg Federation, state or local party and the community.

SECTION 11. POLITICAL MISSION

Within its limits, the Whigg Federation shall foster and aid in the election or appointment

of Whigg candidates at all levels of government.

SECTION 12. EDUCATIONAL MISSION

The Whigg Federation shall promote political awareness and encourage the citizens and students of the American states to investigate and participate in the American political process at the local, state and federal levels of government.

SECTION 13. MISSION SUPPORT

Within its limits, the Whigg Federation shall provide materials, support, and leadership to all Whigg Parties and organizations in the American states, and shall actively work to expand the membership of Whigg Parties and organizations in the American states, by organizing and strengthening Whigg Parties and organizations throughout all regions of the American states.

ARTICLE I

Name:

In addition to Article I of the Constitution of the American Federation of Whiggs, this national organization lays claim to any and all usage of the words Whigg or Whiggs. This word was invented by this organization, contrary to any and all current spellings of the historically significant word "Whig." The double "G" spelling of the word, regardless of case, is intended to maintain a distinction between the remnants of what we believe to be the practitioners of the true and central Whig beliefs of limited government and those contrary beliefs of any now existing

contemporary organizations that have or may yet incorporate the word "Whig" and spelling in the title of their organization. This organization intends the double "G" spelling to literally stand for "Good Government" in practice under any republican form of Whigg government. As stated in our Whigg Constitution, "The name of this organization shall stand for good government and shall be The American Federation of Whiggs (hereinafter referred to as "The Whigg Federation"). The name of the members of the various organizations formed under the Whigg Federation shall be the American Whiggs and/or Whiggs."

We hope that our philosophy shall help usher in a New World Order in all the American states and the states of the rest of the civilized world. A New World Order that we believe was intended by the Whigs that founded our United States Government and wrote our Constitution of the United States of America. Freedom for those who are willing to stand and fight for it, and in peace stand by its' basic rule for a better life for all. A nation ruled by laws, not by men!

In conclusion:

Whigs that belong to our federation are called Whiggs. The Whiggs that belong to our Whigg Federation are the modern equivalent of the Whigs that founded the United States of America. We Whiggs have studied history and know that the principles upon which our American Republic was founded, meet the demands and challenges of our country and the world at large today. We aim to see that our constitutions and laws are adhered to as they were intended to be. We aim to see that all usurpers are exposed and punished.

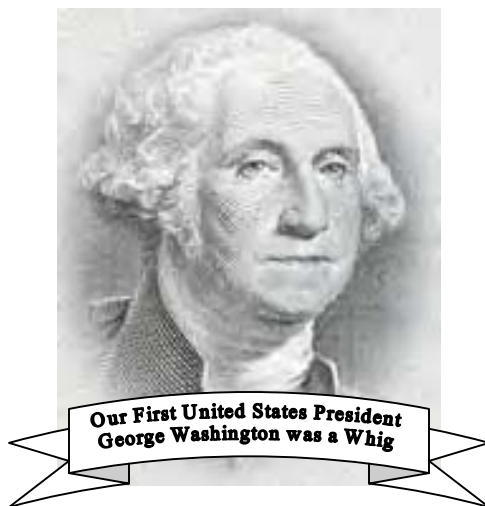
